As Adopter, I agree to the following:

1. Under no circumstances will this pet be sold, leased, or given to any breeder, pet shop, and research lab, used or exploited in any manner other than household pet.
2. This pet will be kept indoors unless otherwise stipulated in this contract and not allowed to freely roam outdoors.
3. This pet is purchased as PET only. Adopter agrees to provide pet with nutritious meals, warm, safe environment and regular vet care.
4. Muttie Crew will provide adopter with current vaccination records and recommended care.
5. To provide a safe collar with rabies and ID tags to be worn anytime is outside the home. Microchipping is highly recommended.
6. To provide all medical care and treatment needed by the animal including but not limited to: yearly medical checkups and vaccines, preventative heartworm medication and flea prevention.
7. To obey all applicable laws governing the control and custody of the animal.
8. If it ever becomes necessary to find the animal another home Muttie Crew will be contacted and given first opportunity to take the animal back.
9. If the animal has not been spayed/ neutered at the time of this adoption, I agree to have the surgery done by (date): _____. In the event I do not have the animal altered by the date agreed upon then ownership of the animal shall revert back to Muttie Crew upon demand.

NO WARRANTY OR GUARANTEE: I understand that every effort is made to offer for adoption only healthy, even-tempered animals. However, some animals are only available for observation by Muttie Crew for a short time, and therefore, no guarantees, nor implied/ expressed warranties with regard to this animal are made. I understand and agree that it is my responsibility to carefully choose the animal I am adopting and that no guarantees are made regarding the health, temperament, or training of animals for adoption. I understand and agree that Muttie Crew shall not be liable, in whole or in part, for any personal injury or property damage caused by this animal, or for any injury or illness of this animal once possession is assumed by the adopter.
